# WI43 - PRIVACY POLICY/PRIVACY STATEMENT v1.18



#### Introduction

Hy-Ram have a need to process personal data relating to its customers in order to fulfil its normal business practices – the manufacture, sale, repair and hire of tools for the pipeline and related industries. Hy-Ram will be compliant with and adhere to the GDPR to make sure personal data is protected both electronically and physically.

#### What we collect and when

Hy-Ram will at various stages throughout your transaction with us collect, store and process the following personal information:

Name, Company, Phone number, Email address, Business Address, Order/Enquiry History.

This information is collected in a number of ways: through our website when you fill out the contact us form, over the phone when you call us, from emails you send us and occasionally from forms you fill out or business cards you leave when you visit us at an exhibition. Sometimes we may receive information from a distributor or a manufacturer regarding an enquiry you have made with them.

Linkedin is a business social network and occasionally we may contact members to offer our services, but only where we believe there is a legitimate interest between both parties.

#### What we use the information for

Hy-Ram use any information collected to:

- Provide a service and meet our obligations to you for example contacting you if there are any queries on your order.
- Inform you of other related services for example emailing you about a new innovative product.
- Make commercial decisions such as pricing.
- Improve our services/products for example by analysing spend patterns.

## What we do not use the information for

Hy-Ram will not sell information for profit or share it with anyone who might. Information will not be shared with anyone for the purposes of marketing anything other than a specific product we believe there will be a legitimate interest in.

### Other data we collect

Hy-Ram collects statistical data from its website including the country you access the website from, what search engine/term you used where this is provided, the time and date of visit. We do not collect your IP address and none of this data can be linked to a particular individual. We use this information to make business decisions about our website and products, such as gauging the popularity of a particular page

### Who we share data with

Hy-Ram will share your information with the following outside parties:

- Business critical services such as a courier service to deliver your order.
- A Hy-Ram nominated distributor or agent for a product you have enquired about.
- Cloud-based electronic services such as Mailchimp.

In all cases the above parties will have been checked by Hy-Ram to ensure they have suitable controls in place to protect personal data.

Hy-Ram may additionally disclose your data to a third party where:

- Obligated to under law
- To enforce or apply terms of use or other agreements
- To protect the rights, property or safety of customers, staff, suppliers and other parties
- Exchanging information with other companies and organisations for the purposes of fraud protection, prevention of money laundering and credit risk reduction

In the process of sharing this information it may be necessary to transfer it outside of the European Economic Area ("EEA"). We will only do so if adequate protection measures are in place in compliance with data protection legislation.

# How long we keep information

Hy-Ram will not retain information indefinitely.

Personal information relating to customers for a maximum of 7 years after their last transaction and/or contact. For individuals who make an enquiry but do not become customers the data will be held for as long as is necessary to ensure effective communication, up to a maximum of 2 years from that individual's last communication.

In some cases data will be deleted before these deadlines, in line with an individual's rights under data protection law.

### Your rights

If you find any data held is inaccurate or incomplete, please contact us using the details at the beginning of this policy and it will be rectified.

You may ask for your information to be deleted under the following circumstances:

- You believe the personal data is no longer necessary for the purpose for which it was collected
- You believe data has been unlawfully processed
- The data needs to be erased to comply with a legal obligation

Pending verification of the above Hy-Ram will, when notified, suspend the processing of your data until a decision is made.

Hy-Ram do not currently carry out automated decision making relating to individuals.

In the event that you are not satisfied with our processing of your personal data, you have the right to lodge a complaint with the relevant supervisory authority, which is the Information Commissioner's Office (ICO) in the UK, at any time. #### Cookies

- Functional Cookies: These are used to recognise you when you return to our website. This enables us to personalise our content for you and remember your preferences.
